**SECTION 4: FIRST AID MEASURES**

**4.1 Description of first aid measures:**

### SECTION 5: FIREFIGHTING MEASURES

#### 5.1 Extinguishing media:

Product is non-flammable under normal conditions of storage, manipulation and use. In the case of inflammation as a result of improper manipulation, storage or use preferably use polyvalent powder extinguishers (ABC powder), in accordance with the Regulation on fire protection systems. #### 5.2 Special hazards arising from the substance or mixture:

As a result of combustion or thermal decomposition reactive sub-products are created that can become highly toxic and, consequently, can present a serious health risk.

#### 5.3 Advice for firefighters:
