



## US FOREST SERVICE AND UL TESTING DIRECTORIES

### USDA FOREST SERVICE WILDLAND FIRE CHEMICALS

Called the “Qualified Products Lists” (QPL) provides a continually updated chart of approved fire suppression chemicals to be used on Federal Lands and are tested for:

- Health & Safety
- Environmental safety and effects
- Corrosion of aircraft, apparatus and equipment

#### QPL Link – Class A Foam

1. To connect to the USFS website, click on the web link <http://www.fs.fed.us/rm/fire/wfcs/>
2. Go to 2nd section and click on, “Class A Foams”

#### SDS link to USFS QPL listed chemicals

1. To connect to the USFS website, click on the web link <http://www.fs.fed.us/rm/fire/wfcs/>
2. Go to the last section, “Protect the safety of firefighting personnel, the general public, and the environment”.
3. Click on the last line “Wildland Fire Chemical Safety Data Sheets”

### UL CERTIFICATIONS (WETTING AGENTS)

This is a performance test certification. Underwriters Laboratories tests and certifies submitted products for use on Class A and Class B fires. This test is called the “wetting agent” test. The lower the percentage of the product needed to pass the test, the higher performance the product has.

1. Click on the link to go to the UL Certifications search page, UL Wetting agent data base.
2. Go to the bottom of the first section, “keyword” space and type in wetting agents
3. Click Search
4. The directory lists all the manufacturers that have submitted and paid UL for the “wetting agent” test. (There should be 3 pages listed at the bottom)
5. Find the name of the company that manufactures the product you are looking for
6. Click on the right side “link to file” to view the certification sheet.

**NOTE:** In the center of the page it states; “wetting agent concentrate, when added to water in concentrations of not less than \_\_% by volume for Class A and Class B fires”. The lower the number in the blank the better the product performs as a wetting agent.
